What is a hip spica?

A hip spica can be described as 'plaster cast trousers'. Hip spicas are made from 'plaster of Paris' and/or resin (a synthetic material), with a soft lining underneath. There are lots of different types of hip spica but generally they start from above your child's stomach and stop just before their ankles. The exact length of your child's hip spica and the position of their legs will depend on your child's condition and surgical needs.

Our range of Hip Spica chairs have been specifically designed for children who are in plaster casts following hip surgery and require supportive seating. We manufacture 3 products in the Hip Spica range: Portable Hip Spica chair, Multi-Adjustable Hip Spica chair and STEPS Hip Spica chair. By placing any order(s), you agree to be legally bound by these terms and conditions.

1. Prices

Prices are in sterling and shown exclusive of VAT. Smirthwaite reserves the right to amend prices at any time and without prior notification. All rental prices are quoted on a daily basis.

2. Rental facts

There is a minimum rental period of 3mths but no maximum. Rental is only available in UK mainland. No capital spend is required. The equipment remains the sole property of Smirthwaite Ltd. We will not provide equipment over 3 years old. We will clean, service and recycle equipment or provide new equipment at our discretion.

Please keep your packaging safely, when you have finished with your chair contact Smirthwaite and we will arrange to pick the chair up. If you no longer have the packaging a charge will be made to send you packaging.

3. Delivery

There is no delivery charge for an order placed with the rental scheme. We will deliver the equipment to any UK mainland destination. We will endeavour to deliver the product to you within 5 days of receipt of your order.

4. Rental termination

If you would like to terminate the rental you must notify our Customer Services team either through e-mail info@smirthwaite.co.uk or telephone 01626 835552. The rental agreement will stop on the day that you notify us.

5. Collection

Once you have terminated the rental agreement. We will arrange for collection of the product at no cost to you.

6. Maintenance

We will maintain the equipment in compliance with the recommended manufacturing standards. For further information please refer to the product's user guide. All of our guides can be found on our website www.smirthwaite.co.uk. At no extra cost to you we will also rectify minor damage as a result of normal wear and tear.

7. Invoicing
